Taylor's guiding principles

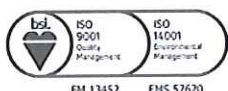
- ✓ Conduct all aspects of our business in a sustainable, responsible and competent manner so as to minimise the potential for pollution and environmental impact.
